#### GENERAL RULES AND REGULATIONS FOR COLLEGE

- 1. The college gives utmost priority for discipline and every one, student or staff, is bound to follow the rules and regulations of the college and maintain strict discipline
- 2. The disciplinary committee consisting of discipline in charge and senior faculty in different departments maintains & enforces strict discipline in the college campus.
- 3. Under disciplinary action, the principal after consulting with disciplinary in charge is empowered to fine, suspend or even expel a student from the college in the interests of the institution.
- 4. Students are not permitted to possess or use Mobile Phones inside the college campus
- 5. Wearing of torn or faded Jeans by students is not permitted except on Saturdays & any one found wearing jeans will not be allowed to enter the College.
- 6. Loitering around in the corridors during the College working hours is prohibited.
- 7. No student can leave the College early without prior permission of the higher authorities (Gate pass issued needs to be produced)
- 8. Students should not ABUSE Language while in campus.

- 9. BROWSING IS NOT ALLOWED DURING LAB HOURS. Staff and students are not allowed to misuse the internet facilities.
- 10. Triple riding is strictly avoided in the campus and will be taken strict disciplinary action against the students who violates.
- 11. Smoking is strictly prohibited in the College Campus and ensures that this is being strictly followed.
- 12. No one will be allowed to listen to Music from any device inside the college campus.
- 13.Every Student shall conduct himself/herself in such a way to cause no disturbance to the working of the classes or to fellow students.
- 14.RAGGING ,CONSUMING ALCOHOL AND SMOKING ARE STRICTLY PROHIBITED IN THE HOSTEL AND COLLEGE CAMPUS
- 15.No function shall be arranged by the students in the hostel or college campus without prior permission from the principal
- 16.Students are not allowed to exchange greeting cards, photographs, gift articles or letters, with Students of opposite sex
- 17. Students should adhere to the dress code prescribed by the college.

- 18. Writing on walls, pillars, bath rooms, and furniture or black boards is strictly prohibited.
- 19.Eating stacks/taking lunch inside the laboratories or along corridors are not permitted

- 20. The cost of any damage, if caused to college property will be charged to the accounts of the students responsible for the damage in addition to disciplinary action.
- 21.Students are advised to switch off fans and lights when they leave the class rooms.
- 22. Furniture in the class rooms should not be moved or displaced
- 23. Students are not allowed to attend classes or any workshops seminars or any other co-curricular events wearing shorts, dhotis, jeans or T-Shirts.
- 24. No one will be allowed to whistle, hoot, shout or sing aloud while travelling in the bus. They are also not allowed to throw papers or other articles while travelling
- 25.No students shall remain in the hostel during class-hours unless be/ she is sick and is permitted to be on leave.
