RULES & REGULATIONS OF THE SOCIETY

1. **NAME OF THE** : PSCMRCET ALUMINI WING
(POTTI SRI RAMULU CHALAVADI MALLIKARJUNA RAO
COLLEGE OF ENGINEERING & TECHNOLOGY ALUMINI
WING ASSOCIATION)

2. **LOCATION** : Door No.7-3-6/1, RAGHAVAREDDY STREET, KOTHAPETA
VIJAYAWADA, KRISHNA DISTRICT, A.P.

3. **ADVISORY BOARD :**

The Advisory Board consists of Eleven Members. Members those who are admitted in the Advisory Board without any payment and whose services and guidelines are considered for the development and activities conducted by the association. The governing body of the Association shall consider the guidelines, advises, services of the Advisory Board. Out of seven members, Founder Board members are the permanent Advisory Board Members : The remaining members are elected from the Governing Body, Advisory Board will guide, advise, render services to the Governing Body.

EXECUTIVE COMMITTEE MEMBERS

The promoters board consists of the members who promoted the and it consists of president, Secretary, Treasurer, Vice President, Joint Secretary, they are the members in General Body and have rights like other General Body Members.

4. **MEMBERSHIP :**

The Association shall have the following Two Classes of members i.e., as Life Members and Members.

MEMBERSHIP : Any student who has spent two years of study in PSCMRCET ALUMINI WING, vijayawada.

- a. i) The members shall pay such an amount towards annual subscription as decided by the board.
ii) Life membership fee shall be Rs.500.00.

5. **PENALTY FOR DEFAULT IN PAYMENT OF MEMBERSHIP FEES :**

Any member who is in arrears of Membership fee for a continuous period of two years shall **IPSO FACTO** ceases to be a member of Association and shall not have access in

the Association and shall not have access in the Association and shall not participate and vote at the meeting. Any member whose membership ceased may be readmitted with the recommendation of Governing Body and on the payment of all his arrears and the penalty equal to the dues.

6. EXPULSION OF THE MEMBERSHIP :

A member may be expelled from the Association for mis-conduct or acting against the interests of the Association or on conviction in criminal case or any other sufficient reason or any cause by resolution passed at a meeting specially convened for the purpose at which the resolution is favoured by 3/4th Majority of the members attending and voting. No members shall be removed from the association except under the above rules and circumstances.

7. MEETING OF THE MEMBERS :

The members shall meet once in every year Month of **July** called **THE GENERAL BODY MEETING** and the following points shall be transacted there at :

- a) Annual Report shall be considered.
- b) Acceptance of Accounts of the previous year and Auditor's Report
- c) Approval of Budget for the current year by the newly elected officer Bearers.
- d) The consideration of any other subject that may be brought forward by the president or Secretary or any member with the permission of President.

8. QUORUM :

The Quorum for all the **GENERAL BODY MEETINGS AND EXTRA ORDINARY SPECIAL MEETINGS** shall be 1/3rd of Attending Members.

9. a) EXTRA ORDINARY GENERAL BODY MEETING :

The president or secretary shall convene a Extra ordinary general body meeting on the written requisition of members to discuss the subject mentioned in the requisition. No other subject can be discussed in Extra ordinary general body Meeting which is not mentioned in the above requisition.


b) SPECIAL MEETING :

Members in the advisory board and executive committee only be the members in the special body meeting. The quorum for conducting the meeting is 1/3rd of the members.

10. ELECTION MEETING :

On consultation with president, the General Body Meeting shall be convened by the Secretary with one month clear notice for the purpose of election of office Bearers and Executive Members.

11. NOTICE OF THE ELECTION MEETING :

TWENTY ONE DAYS PRIOR NOTICE FOR GENERAL BODY MEETING AND FOURTEEN DAYS NOTICE FOR EVERY EXTRA ORDINARY SPECIAL MEETING SHALL BE GIVEN TO MEMBERS. General secretary shall obtain acknowledgment receipts of notice circulars from office bearers of general body in respect of meeting of general body & special meeting. A copy of the notice of every meeting shall be affixed on the college notice board on the same day notice issued.

12. OPINION OF MAJORITY PREVAILS :

In all matters and in all meetings the opinion of the majority of the members attended shall prevail and in the case of tie or equality of votes the president shall have an additional or casting or deciding vote.

13. MINUTES BOOK & CORRESPONDENCE FILE :

The proceedings of every meeting shall be recorded in the minutes book kept for the purpose of recording by the Secretary. The contents should be read at the same meeting and signed by the president. Correspondence file shall be maintained by the Secretary and shall be informed to president.


13. GOVERNING BODY / EXECUTIVE COMMITTEE :

The Governing Body / Executive Committee consists of 7 members and they are elected from the General Body - President, Secretary, Vice President, Joint Secretary, Treasurer, treasurer Two Executive Members four lady members and five male members and they hold office for a period of three years. The Governing Body shall manage the affairs of the Association and carry out the aims and objects of the Association with the advise of the Advisory Board. The secretary of the PSCMRCET ALUMINI WING Committee and the principal of PSCMRCET ALUMINI WING shall be the Ex-office Members in the Governing Body. The Governing Body shall be the Executive Committee.

14. THE ABOVE MEMBERS OF GOVERNING BODY SHALL BE ELECTED AT A GENERAL BODY MEETING BY MEMBERS OF ASSOCIATION UNANIMOUSLY OR BY CASTING OF VOTES BY MEMBERS. The above Governing Body thus elected shall serve the Association for a period of THREE YEARS only.

15. PROCEDURE FOR THE ELECTION OF OFFICE BEARERS AND MEMBERS OF GOVERNING BODY : Election notice shall be circulated among the members of Association by the Secretary and also affix of such notice in the notice board. The notice shall be given atleast one month before the election. The Election other shall receive all the nominations for the post of office Bearers and members of Governing Body and they are Scrutinised by the him.

6. **ELECTIONS** : Elections of the association shall be made in last week of march and the new body shall take oath on **3 years**.
17. Election Officers appointed by Governing Body will Conduct elections with the co-operation of Secretary.
18. Election Officers shall announce results of newly elected office bearers and other members of Governing Body. **PRESIDENT AND SECRETARY** and other members shall handover the charge to the newly elected office Bearers.
19. Old Governing Body only continues till new office Bearers take over the charge.
20. Only Life Members are eligible to contest in the elections of Governing Body / executive committee.
21. For the efficient management of the Association, separate Committees may be appointed by the Governing Body, President and Secretary of the Association shall be Ex-Office Members of all the Committees.

22. **FILLING OF VACANCIES IN THE GOVERNING BODY :**

If vacancy occurs in any one of the aforesaid office bearers, it shall be filled by the other members of Governing Body by co-opting from them and for such vacancy in other members shall be filled by governing body from life members.

23. **QUORUM :**

The Quorum for Governing Body Meeting shall be 2/3rd of attending members for meeting.

PRESIDENT :

- a) The president of the Association shall preside all the meetings i.e., GENERAL BODY MEETING, SPECIAL MEETINGS & GOVERNING BODY MEETINGS.
- b) The president shall exercise general supervision over the work of Secretary, Treasurer and the Governing Body Members.
- c) The signature of the president is a must for the resolutions passed and recorded in the minutes book.

VICE PRESIDENT :

Vice president shall perform all the duties of president in his absence.

THE SECRETARY :

The Secretary of the Association shall convey all the meeting i.e., Governing Body Meeting, Extra ordinary General Body and special Meeting with consultation of the

president. The Secretary shall have power to employ from time to time such employees as may be require for the welfare of Association and to Control and remove them and to pay salaries and wages. The Secretary shall sign all the correspondence files on behalf of the Association and the same should be informed to the president.

JOINT SECRETARY :

Additional Treasurer shall perform all the duties of treasurer in his absence.



26. The Treasurer may retain with him a sum of Rs.5000-00 for current & PETTY expenses and all the expenses under Rs.5000-00 may be incurred by him. Any expenditure exceeding Rs.5000-00, the payment should be paid by cheque.

27. AUDIT AND LEGAL ADVISOR :

The Auditors Report of the Association shall be checked and accepted by the General Body meeting once in a year. The Governing body shall appoint Auditor and Legal Advisor to serve the Association for a period of three years at remuneration fixes by the Governing Body.

28. PURCHASE OR SALE OF MOVABLE OR IMMOVABLE PROPERTIES :

All shall purchase or sell the movable or immovable property of the association shall be made in the name of the Secretary and he shall represent the association for the same.

29. RESERVE FUND :

The association shall open an account for the reserve fund in schedule bank and amounts received by way of donations shall from the reserve fund and association shall utilize these amounts for fulfillment of objects of the association.

30. AMENDMENT OF REGULATIONS AND OBJECTS OF THE ASSOCIATION :

The rules and regulations may be modified or altered and new objects may be inserted by passing necessary resolutions with 2/3rd majority of attending Member and voting in GENERAL BODY MEETING OR SPECIAL MEETING called for the purpose.


