(b) The candidate should carry out the corrections, if any in the thesis suggested by the examiners before the Public Viva Voce examination.

(c) The guide shall convene the Public Viva Voce examination, for the candidate, whose thesis has been commended for the award of degree in the presence of one of the examiners, who evaluated the thesis, chosen by the guide and shall convey the result of the viva voce examination together with the list of participants, to the Controller of Examinations.

A candidate whose thesis has been recommended for re-submission with revision by the examiner, may be permitted to resubmit the thesis within a period of one year from the date of receipt of the intimation. The thesis shall be reevaluated by the same examiner.

A candidate who is successful at the Public Viva Voce examination shall be declared to have qualified for Ph.D. degree. The provisional certificate will be issued to the candidate within 15 days and the Degree will be awarded in the subsequent convocation notified by the Mahavidyalaya. Such degree will contain the words " this degree has been awarded in accordance with the regulations of UGC". Soft copy of the thesis will be sent to UGC through section of the controller of examinations with in 30 days from the date of award of Ph.D degree.

If candidate is not successful in the public viva voce examination, he /she may be permitted to take another public viva voce examination after a period of three months from the date of the first viva voce examination.

If the report from the examiner/s is not received within 60 days from the dispatch of the thesis, a reminder shall be sent by the controller of examinations to the examiner/s. In case of non receipt of report from the examiner within the next 30 days, the Vice Chancellor will select another examiner from the panel of examiners suggested by the guide. The evaluation process should be completed within 120 days from the date of

Chairman, the respective Head of the Department or his nominee, an external expert as members and the Registrar as the secretary. The Committee will initially ask the candidate for a written examination and a presentation in the field of his research so as to judge the ability of research aptitude and motivation of the candidate to complete the research work. An evaluation report given by the committee will be placed before the Vice Chancellor who at his discretion will select and admit the applicant to work under the guide proposed. The provisional registration of the candidate will be effective from the date of payment of fee for admission.

Candidates selected for admission shall pay the prescribed fees, every year till the submission of thesis, as given in Appendix - A. If the candidate fails to remit the fees in time a fine will be collected which is deemed fit by the university authorities. In case of internal candidates the collection of fee will be limited to three years only.

2.1 Full time:

A candidate registered as full time candidate for the Ph.D. Degree possessing any one of the qualifications prescribed in 1.1 shall work continuously in the department under the supervisor concerned for a minimum period of Three years after provisional registration before submission of thesis.

2.2 Part time:

A candidate registered for Ph.D degree as a part time candidate (internal or external) shall work for a minimum period of four years after provisional registration before submission of the thesis.

2.3 Period of Research

No candidate shall ordinary be permitted to submit his / her thesis after a period of four years (in the case of full time scholar) and five years (in the case of part time scholars). On the recommendation of the Research Guide, the Vice-Chancellor may grant extension for not more than two terms, each term consisting of a period of six months, subject to satisfaction of the research progress made by the scholar.

2.4 Exemption:

Exemption of one year from the minimum duration required is permissible in respect of candidates who possess an M.Phil or M.Litt in Arts and Science or Master's degree in the Faculty of Engineering, and Technology.

2.5 Conversion:

The Mahavidyalaya may permit conversion from Full-time research to part time research and vice versa in respect of candidates registered for valid reasons and subject to satisfying the rules, regulations and conditions in force. The period put in by the candidate will be worked out in the ratio of 2:3 for research put in before and after conversion and vice versa. This is left to the discretion of the Mahavidyalaya.

3.0 Guide / Supervisor for research:

- 3.1 Candidate shall identify the guide for the proposed research programme and shall work under the continuous supervision of the guide. If university department has got a recognized guide a scholar should opt for his guidance as his first choice. If university department recognized guide finishes his stipulated quota then he will perform the role of a co guide. If there is no department in the university where in a scholar opts for pursuing Ph.D ,university authorities when they are confident such research topic will bring reputation to university ,upon satisfactory procedures may admit such scholar in to the programme .An expert in the field in which the scholar is pursuing Ph.D will be identified by university research monitoring committee duly constituted for the purpose and they will monitor the progress of the research of the candidate.
- 3.2 In case of candidates who wish to carry out inter-disciplinary research, the applicant must identify a co-guide from the relevant field apart from the guide in the concerned department of study. If the co-guide belong to an academic institution he/she should possess a Ph.D degree in the relevant field. Otherwise if he/she is from an industry/ R&D institution an

equivalent experience may be considered even without a Ph.D., degree with the approval of vice chancellor. Registration shall be granted in the parent discipline of the candidate only.

- 3.3 If the guide of the candidate has not been approved by the Mahavidyalaya authorities at the time of applying, the registration for Ph.D. will be done only after the guide is duly recognized by the Mahavidyalaya.
- 3.4 A person may be recognized as a guide for Ph.D programme in any faculty, if he /she possesses a Ph.D. Degree of this Mahavidyalaya or of any other university recognized by the Board of Management of this Mahavidyalaya as equivalent thereto and has a minimum of two years of teaching/research experience after obtaining Ph.D degree, with a minimum of two research publications in standard refereed journals/proceedings of international seminars/conferences or equivalent published work like books to his credit with in a period of three years preceding his/her date of application for recognition.
- 3.5 For any recognized guide, the total number of candidates of Mahavidyalaya registered under him for Ph.D, including part time candidates, at any point of time shall not exceed five.(eight can be the maximum number as per current UGC guidelines)
- 3.6 For every candidate registered for the Ph.D. degree, a doctoral committee of not less than three faculty members shall be constituted by Dean (R&D), consisting of the guide of the candidate as member whose presence is mandatory , the Head of the Department concerned or his nominee and a subject expert suggested by the guide. In case of interdisciplinary research, the co-guide shall also be a member. If the Head of the Department happens to be the guide, the Vice Chancellor will nominate a senior member of the staff of the concerned Department in the place of the Head of the Department. The doctoral committee will have the functions as prescribed in appendix B.

3.7 Change of topic of research:

A candidate shall select and furnish the research topic within the period of one year from the date of registration. If a change of topic becomes necessary, the candidate is permitted to change the topic already given up to a period of one year for full-time and two years for part-time from the date of registration. Whenever a candidate seeks permission for change of topic after the permissible period, he/she would be permitted to submit the thesis only after three years in the case of full-time and four years in the case of part-time candidates from the date of approval of the change of topic.

3.8 Change of guide:

If change of guide becomes necessary for any candidate, he/she may be permitted by the Vice Chancellor to change the guide on request from the candidate only once. The research scholar will be permitted to work and submit his / her thesis under the guidance of the same guide even after the retirement of the guide.

4.0 Course Work

- 4.1 A candidate who has registered for Ph.D. degree (full time and part time) shall successfully complete the examination consisting of two papers i) Research methodology and ii) Paper related to the subject of research (one additional paper in case of inter-disciplinary candidates) after one year and before a maximum period of two years for full time candidates and after two years and before a maximum period of three years for part time candidates from the date of provisional registration.) In case the candidate does not complete methodology exam for whatever may be the reason he has to re-register for continuance. Methodology examinations will be conducted through individual school/department level under the guidance of controller of examination section.

- 4.2 Provisional registration for Ph.D. will be confirmed as confirmed registration only after successful completion of the methodology examination.
- 4.3 The candidate shall enclose the original communication of the Mahavidyalaya, as a proof of having passed the examination, at the time of submitting the thesis.
- 4.4 The candidates with M.Phil (with dissertation) or M.Litt (with dissertation) are exempted from taking written research methodology paper but will have to take the paper related to the subject of research. If the topic of research in Ph.D is a continuation of M.Phil dissertation the candidate shall be exempted from taking the paper related to the subject of research also.

5.0 Synopsis and thesis submission

- 5.1 Every candidate shall submit a synopsis (6 copies; each copy typically not exceeding 10 pages) of the proposed thesis through the guide, six months before the submission of the thesis, in the prescribed application form he/she need to submit one soft copy of the synopsis in single PDF file in a CD form. (appendix H).before submitting the synopsis the candidate has to appear for pre synopsis presentation where in faculty and students will be invited to understand the topic and for giving feedback for improvement if any. Once the panel feel the synopsis is in order they recommend for its submission.
- 5.2 The candidate shall submit five copies of the thesis, not earlier than three months after the submission of the Synopsis, in the prescribed application form and not later than six months after paying the prescribed fees along with a soft copy of the thesis in a single PDF file in a CD.
- 5.3 In case the candidate fails to submit the thesis (after submission of the synopsis) within the stipulated time, he/she has to resubmit the synopsis.

- 5.4 The title page, covers, format etc., should strictly conform in presentation as prescribed in appendix C and all copies of the thesis should carry a declaration by the candidate (appendix D) and a certificate by the supervisor (appendix E)
- 5.5 The candidate is expected to have published at least two papers in a refereed Standard Journal/s (NATIONAL/INTERNATIONAL) before submission of Synopsis.
- 5.6 The medium of presentation of the Thesis shall be English/Sanskrit (Devanagari Script)

6. Adjudication of Ph.D. Thesis

The Vice-Chancellor shall appoint a Board of Examiners for evaluation of thesis, consisting of the guide as the convener and two other external examiners from the panel of minimum six experts or maximum nine from reputed institutes suggested by the Guide for the candidate. At least four of them are to be from different parts of the country and couple of them preferably from foreign countries.

The two external examiners so appointed shall evaluate the thesis and send a report on the thesis in the prescribed proforma (Appendix F) to the Mahavidyalaya, along with a detailed report on the thesis. The controller of examinations will send the reports to the convener. The convener of the Board of Examinations shall submit a consolidated report on the thesis to the Mahavidyalaya.

If one of the two external examiners does not commend the thesis for the award of the degree, a third examiner, selected by the Vice Chancellor from the existing panel recommended by the guide, shall evaluate the thesis and if he/she also does not commend the thesis for the award of the degree, the registration of the candidate will be cancelled.

- (a) If two external examiners commend the thesis for the award of the degree, the candidate will be asked to appear for a Public Viva Voce examination.
