Force majeure:

Neither party shall be liable for any failure or delay in its performance due to circumstances beyond its reasonable control, provided that it notifies the other party as soon as practicable and uses its best efforts to resume performance.

Indemnity:

Each party shall indemnify and keep indemnified, defend and hold harmless the other party and their respective officers, directors, employees (collectively the "indemnified persons") from and against any and all direct losses, claims, costs, liabilities, judgments, expenses or damages that the indemnified person may incur or suffer as a result of or arising out of breach of any representation made by it under this agreement.

Severability:

If any part or any provision of this MOU becomes illegal, invalid or unenforceable, that part or provision shall be ineffective to the extent of invalidity or unenforceability without in any way affecting the validity or enforceability of the remaining parts of said provision of this MOU. Waiver:

Failure of party to exercise promptly any option or right granted, or to require strict performance of any obligation herein imposed shall not be deemed to be a waiver of such rights or of the right to demand subsequent performance of any and all obligations herein imposed.

Amendments:

All changes and amendments to this agreement or to any attachment there to be valid only if made in writing and signed by duly authorized representatives of both the parties.

Dispute resolution:
